Dear IASO members

Cancer patients diagnosed with cancer in India per year is reaching to almost fifteen lakh new cases per year and more than half of these patients are dying of cancer sooner or later. Non-uniformity of treating facilities across the country making it difficult for cancer control. Canceronomics is a big challenge today with high rise of treatment cost and affordability disparity. Most of these cancers are solid tumors and cancer surgery is an integral part of the treatment and contributes significantly to the survival of the patient as R0 resection only way to achieve the desired outcome.

India is vast country with variable treatment facility at first second and tier three cities. For the country at large, proper training in cancer surgery and availability of trained man power in cancer surgery are real needs of the hour with growing armamentarium like laparoscopic / robotic cancer surgery. At present per year nearly 350 new cancer surgeons are getting trained all across India. There are many hinderances in uniformity in training across country unable to give a back up bench strength for cancer control.

This include issues like uneven distribution of the training facilities in the country, non-uniformity of training modules across various institutions, lacunae in skill and knowledge updation of the practising surgical oncologists and lack of job opportunity for passing out cancer surgeons. Leaders in oncology heading various major institutes, many are members in committees deciding the curriculum of medical education and public health care in the country and many are involved in training a large number of surgeons in Surgical Oncology. I strongly feel that it is the responsibility of IASO is to act as conduit between these leaders who are also international stalwarts in surgical oncology, to young budding onco-surgeons and use their collective opinions, power and actions to create better environment for the younger onco-surgeons and cancer surgery in the country.

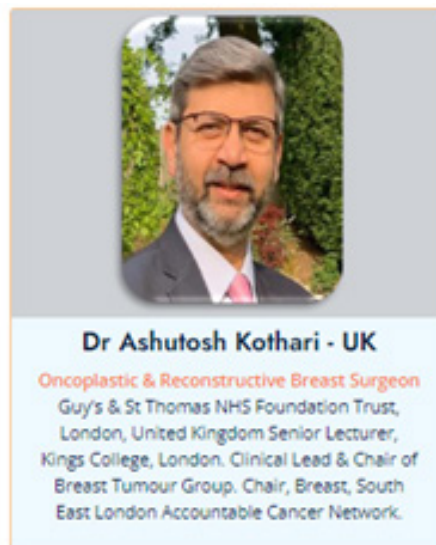

MINUTES OF MEETINGS (MOMS)

MOM OF THE ANNUAL IJSO EDITORIAL BOARD & IASO EXECUTIVE COUNCIL MEETING

ICC Mumbai, 2nd Nov 2023

Date: 2nd November 2023 | Time: 04:30 PM | Venue: Jio Convention Hall

Meeting was called to order by President Dr P K Das and requested to Dr Vijay Kumar (in absence of Dr K Gopinath) to take the agenda and proceed.

- **Proceeding of the joint** meeting of IJSO- IASO annual editorial board meeting held on 6 October 2022, at 05:30 pm at Madurai in courtyard Marriott hotel was discussed.
- The IJSO REFOMS COMMITTEE report was presented by Dr P K Das and Dr Shaikat Gupta in absence of Dr Harit Chaturvedi(who joined later). The said report was already circulated to all the stakeholder of this editorial board by email, in interest of time.
- Dr Das highlighted that the committee was comprised of 5 past presidents, current IASO president and secretary and top two editors on board, which was formed by EC and accepted by the GBM during Madurai NATCON 2022. This committee headed by Dr Harit Chaturvedi, met about 5 times during the year and came out with recommendation. The said recommendation were presented twice to the IASO EC committee. The committee recommended the following for restructuring and streamlining of the editorial board of IJSO.

Structure of Revised Editorial Board

• Editor in Chief (One)

He will play the role of Chairperson and mentor, term of 5 years and will step in only when there is a problem for which the Editor seeks his/her help. In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post. The decision of IJSO selection board is final.

Eligibility: 10 years membership and 25 Publications

(Regarding publications the selection board can overrule this rule if required)

• Executive Editor (One)

Will be working with the Editor in Chief. Executive Editor is the face of the journal, with a term of 5 years.

Eligibility : 10 years membership and 25 Publications

(Regarding publications the selection board can overrule this criteria if required)

• Joint Editors (Four)

Under the Executive Editor, there will be four Joint Editors, one of them will be an International Joint Editor. **Their term will be 4 years each.** In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post and the decision of IJSO selection board is final.

Eligibility : 8 years membership and 15 Publications

(Regarding publications the selection board can overrule this criteria if required)



• Sectional Editors (Eight)

Under each Joint Editor, there will be 2 Sectional Editors, with a term of 3 years each. Eligibility criteria will include IASO membership, number of publications, extent of involvement with IASO activities and term as a reviewer. They can be renominated any number of time by the IJSO Editorial board, based on their performance.

Eligibility : 7 years membership and 10 Publications

(Regarding publications the selection board can overrule this criteria if required)

• Reviewers

Under each SE, there will be Reviewers. Term is of two years.

Eligibility : May not be IASO Member and having 5 publications.

The journal official has to complete his/her tenure in IASO/IJSO before assuming the office for any of the posts except reviewer.

The Journal Structure

This will be a hierarchical system where candidates will climb up the ladder from Reviewer upwards. In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post and the decision of the IJSO selection board and the Editorial board is final.

The Editor chief and Executive Editor, should be exclusively with IJSO. All these posts including that of reviewers should be selected from IASO members only, under the exceptional circumstance that, for a specialized subject, a peer review by a non IASO member is required, and approved by the IJSO Editorial Board. Applications for Reviewer posts can be through IASO website or by nomination. Reviewers will be rewarded with certificates etc.

In any of the committees, if the member likes to be considered for any posts being considered by the committee, he/she will be neither attending the selection meeting nor will have the voting right.

For eg. If IJSO Selection board while deciding the next Editor in Chief, if the present Editor in Chief is reconsidered, he can't be part of selection and won't have voting right.

Nomination for the posts of Journal

- The nominations should come from eligible candidates following notifications from IASO. If there are no/enough nominations for a post, the board/committee can select eligible candidates.
- If a person is a candidate for any appointment, then that person must opt out of the selection committee.
- Joint editors and above positions shouldn't hold post in any other surgical oncology journal, to avoid any conflict of interest.

IJSO selection Board

This board consists of 7 members including:

1. Five Presidents in line (Past president, Immediate past, President, president elect, Vice President)
2. Existing Editor in Chief
3. Executive Editor

This selection board will select- EIC, Executive editor and 4 Joint editors. In case of tie, the current president will have veto power.

IJSO Editorial selection board

This board consists of 9 members including:

1. IASO president
2. IASO President-elect
3. IASO Vice President
4. IASO Secretary
5. Editor in Chief
6. Executive Editor
7. Joint editors (03), excluding international JE

IJSO Advisory board

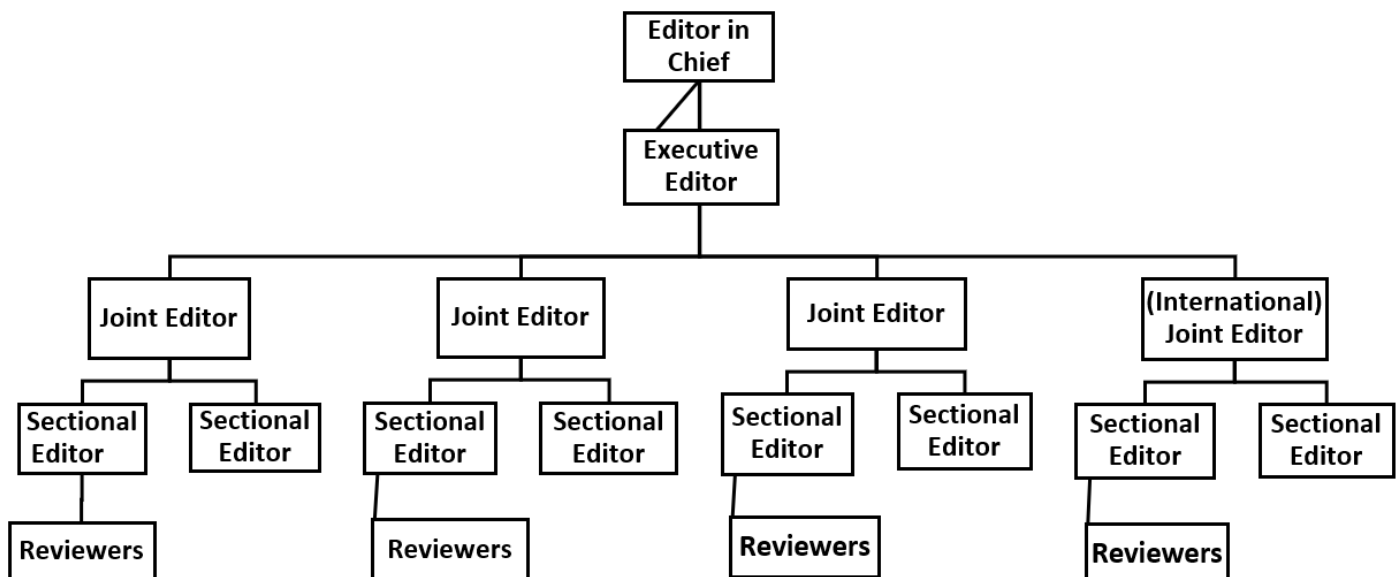
Five national & international advisors for the term of the editorial board to be nominated by the IJSO selection board. All the past chief editors will be considered for inclusion in advisory board.

Timeline

- These minutes will be circulated in November 2023 Newsletter
- After 3 months, IASO will ask nomination for different post via mail/newsletter/ website.
- In March 2024, the IJSO Selection Board will select the Chief Editor, Executive Editor, and Joint Editors and subsequently Editorial Board will select remaining team.

All decisions were unanimously accepted.

Transition of IJSO editorial board structure:

Dr Vijay Kumar (Associate editor) was re-nominated as Executive editor, who would complete the 5 year term since his date of joining as Associate editor. This recommendation after putting in IASO EC on 2nd Nov 2023 & in GB on 3rd Nov 2023 and subsequently in Nov 2023 newsletter, will have legal validity after 3 months. Somewhere in mid feb 2024, the vacant post of editor in chief (01), Joint editor (03) will be advertised on IASO website and members will be communicated by emails as well. The previously submitted application invited during 2022, will also be considered for the said posts. During MIDCON march 2024 Hubballi/ Virtual meeting, the IJSO selection board will select those 04 posts as per the laid guidelines submitted by the honourable IJSO reforms committee. Subsequently, these 05 editors along with IASO president, president elect, vice president and IASO secretary will select 08 sectional editors from the submitted applications for the said post. This selection can be done by zoom meeting with in one month of MIDCON 2024 to form the complete editorial board.

Subsequently, Five national & International advisors for the term of the editorial board to be nominated by the IJSO selection board. All the past chief editors will be considered for inclusion in advisory board.

1. President in Chair called meeting to be in order.

2. **The minutes of meeting of combined IJSO-IASO EC dated 2nd Nov 2023** were read by editorial secretary and passed for GB approval.

3. **IASO Textbook of Surgical Oncology committee report-** read by Dr Arnab Gupta

During the EC meeting on 29/ 06/2023, A 9 member committee was formed comprising of Dr Arnab Gupta, Dr Rajendra Toprani, Dr P K Das, Dr S V S Deo, Dr Sharad Desai, Dr Chandramohan, Dr Somasekhar, Dr Shaikat Gupta and Dr Asutosh Mishra under the chairmanship of Dr Arnab Gupta, to formulate the Aim, Organogram, nominations of Editors and Sectional Editors, appointing a publisher etc.

Accordingly, the committee met first on 17/ 08/ 2023 where the following were discussed:

Name of the Book: Textbook of Surgical Oncology

5. NATCON MIDCON Bluebook- final report prepared by Dr Ashutosh Mishra, Dr Ramesh M, and Dr Chandramohan K was also passed by EC.

6. IJSO Reforms Committee report - The IJSO COMMITTEE report was produced by Dr Harit Chaturvedi. The said report was already circulated to all EC members by email, in interest of time.

Dr Harit highlighted that the committee was strong enough, comprising of 5 past presidents, current IASO president and secretary and top two editors on board, which was formed by EC and accepted by the GBM during Madurai NATCON 2022. The committee headed by him met about 5 times during the year and came out with recommendation after lot of brainstorming sessions and presented twice to the EC committee of IASO. The committee recommended a revised organogram, comprising:

Structure of Revised Editorial Board

• **Editor in Chief (One)**

He will play the role of Chairperson and mentor, term of 5 years and will step in only when there is a problem for which the Editor seeks his/her help. In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post. The decision of IJSO selection board is final.

Eligibility: 10 years membership and 25 Publications

(Regarding publications the selection board can overrule this rule if required)

• **Executive Editor (One)**

Will be working with the Editor in Chief. Executive Editor is the face of the journal, with a term of 5 years.

Eligibility : 10 years membership and 25 Publications

(Regarding publications the selection board can overrule this criteria if required)

• **Joint Editors (Four)**

Under the Executive Editor, there will be four Joint Editors, one of them will be an International Joint Editor. Their term will be 4 years each. In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post and the decision of IJSO selection board is final.

Eligibility : 8 years membership and 15 Publications

(Regarding publications the selection board can overrule this criteria if required)

• **Sectional Editors (Eight)**

Under each Joint Editor, there will be 2 Sectional Editors, with a term **of 3 years each**. Eligibility criteria will include IASO membership, number of publications, extent of involvement with IASO activities and term as a reviewer. They can be renominated any number of time by the IJSO Editorial board, based on their performance.

Eligibility : 7 years membership and 10 Publications

(Regarding publications the selection board can overrule this criteria if required)

• Reviewers

Under each SE, there will be Reviewers. Term is of two years.

Eligibility : May not be IASO Member and having 5 publications.

The journal official has to complete his/her tenure in IASO/IJSO before assuming the office for any of the posts except reviewer.

The Journal Structure

This will be a hierarchical system where candidates will climb up the ladder from Reviewer upwards. In the journal hierarchy, from the post of JE upwards, one can serve more than one terms in the same post and the decision of the IJSO selection board and the Editorial board is final.

The Editor chief and Executive Editor, should be exclusively with IJSO. All these posts including that of reviewers should be selected from IASO members only, under the exceptional circumstance that, for a specialized subject, a peer review by a non IASO member is required, and approved by the IJSO Editorial Board. Applications for Reviewer posts can be through IASO website or by nomination. Reviewers will be rewarded with certificates etc.

In any of the committees, if the member likes to be considered for any posts being considered by the committee, he/she will be neither attending the selection meeting nor will have the voting right.

For eg. If IJSO Selection board while deciding the next Editor in Chief, if the present Editor in Chief is reconsidered, he can't be part of selection and won't have voting right.

Nomination for the posts of Journal

- The nominations should come from eligible candidates following notifications from IASO. If there are no/enough nominations for a post, the board/committee can select eligible candidates.
- If a person is a candidate for any appointment, then that person must opt out of the selection committee.
- Joint editors and above positions shouldn't hold post in any other surgical oncology journal, to avoid any conflict of interest.

IJSO selection Board

This board consists of 7 members including :

4. Five Presidents in line (Past president, Immediate past, President, president elect, Vice President)
5. Existing Editor in Chief
6. Executive Editor

This selection board will select- EIC, Executive editor and 4 Joint editors. In case of tie, the current president will have veto power.

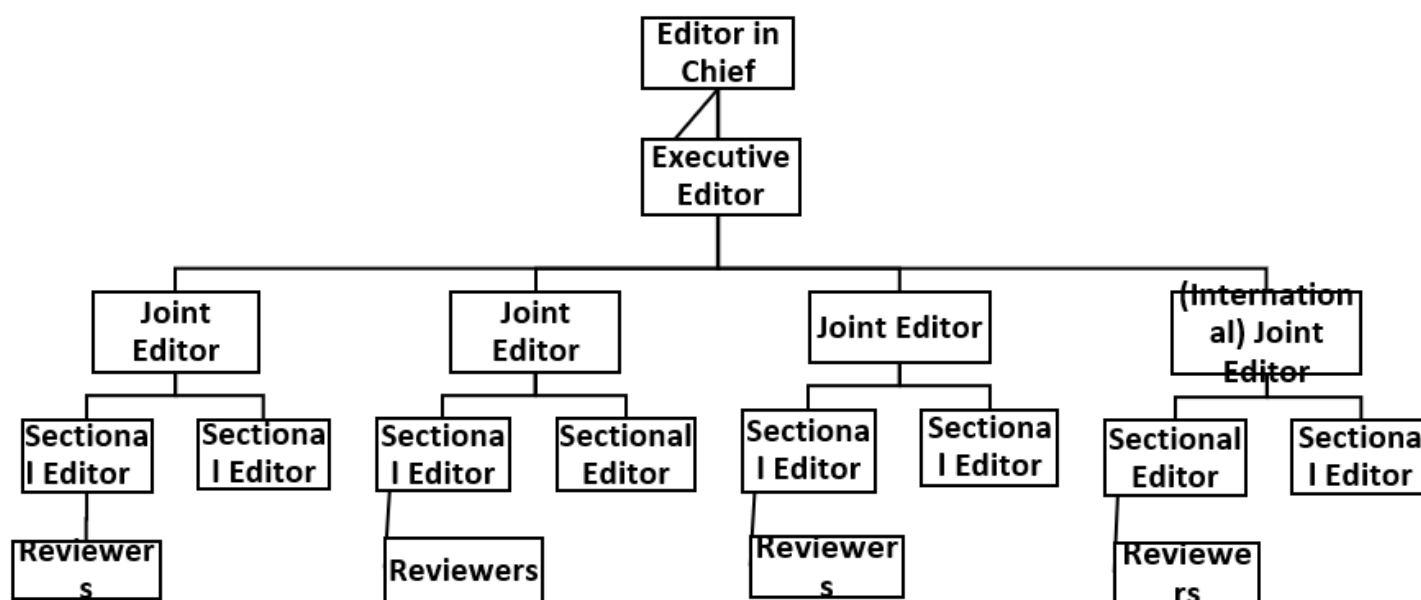
Five national & international advisors for the term of the editorial board to be nominated by the IJSO selection board.

Timeline

- These minutes will be circulated in November 2023 Newsletter

- In March 2024, the IJSO Selection Board will select the Chief Editor, Executive Editor, and Joint Editors and subsequently Editorial Board will select remaining team.

Transition of IJSO editorial board structure:

Dr Vijay Kumar (Associate editor) was re-nominated as Executive editor, who would complete the 5 year term since his date of joining as Associate editor. This recommendation after putting in IASO EC on 2nd Nov 2023 & in GB on 3rd Nov 2023 and subsequently in Nov 2023 newsletter, will have legal validity after 3 months. Somewhere in mid feb 2024, the vacant post of editor in chief (01), Joint editor (03) will be advertised on IASO website and members will be communicated by emails as well. The previously submitted application invited during 2022, will also be considered for the said posts. During MIDCON march 2024 Hubballi/ Virtual meeting, the IJSO selection board will select those 04 posts as per the laid guidelines submitted by the honourable IJSO reforms committee. Subsequently, these 05 editors along with IASO president, president elect, vice president and IASO secretary will select 08 sectional editors from the submitted applications for the said post. This selection can be done by zoom meeting with in one month of MIDCON 2024 to form the complete editorial board.

Subsequently, Five national & International advisors for the term of the editorial board to be nominated by the IJSO selection board. All the past chief editors will be considered for inclusion in advisory board.

7. Revival of IASO-BASO-Hyderabad Fellowship-

To be taken forward by Dr SVS Deo in his future meeting with the BASO president.

8. MOU with SSO, ESSO, BSSO, JSCO, SLASO-

EC passed the decision to sign MoU with ESSO and SSO during ICC. Similar MoU was proposed for NATCON and MIDCON OC.

It was also proposed for fixed amount contribution by NATCON and MIDCON, Rs 15 lac and 7.5lac respectively. ESSO MoU is ready to be signed here during ICC, Rest will be done by email communication.

9. Treasurer Report for IASO-Dr Somashekhar (attached)

10. Decision regarding 12A and 80G registration-

Keeping Membership admission fees aside, if we can incur expenses wisely upto 85% of total income, we can apply for 12A registration. If there is a further scope of similar expenses, we can also go for 80 G registration. EC discussed and approved the matter.

Dr P K Das apprised the members

- **In response to the email of from Dr Bilimaga: ,org secretary ICC 2017**

“Originally there were 9 issues raised and the total penalty was the amount of Rs. 2,42,30,253/-. After our reply to the objections, they dropped few issues, and finally, only 5 issues are still remaining, this penalty amounts totalling Rs. 69,49,220/- and we could able to salvage Rs. 1,72,80,330/-. We are further representing through our auditor to minimize the penalties. As per advice given by our auditor, it is advisable to pay the principal amount of Rs. 35,50,526/- which will avoid further accumulation of interest in case we fail to convince the authorities.”

Who has appealed to each pillar society to help a pay back of Rs 10 Lacks to ICC to meet the GST liability of Rs 35,50,526. IASO had already received back its seed money 10 lacs and a profit share i.e., Rs 20 lacs from ICC 2017 by 2018... As per available information the other three societies ISO, ISMPO and AROI have also agreed to pay back the amount Rs 10 lacs each.

- After a brainstorming discussion by many of the members, The EC decided to ask for the following informations from ICC 2017 so as to go for any concrete decision.
- 1. Name of the Local Host Association on which PAN card was used, apart from 4 pillar societies
- 2. What was the total income, total expenditure including Tax and Total balance amount of profit
- 3. Out of total profit, how much was distributed to the beneficiary Associations/bodies/agencies before closure of

account, with their names.

- 4. If ICC wants to get back those (35 +) Lacs to meet the principal demand of GST, it is implied that the beneficiaries should contribute back proportionately and please let us know such details so that we know our portion.
- 5. Whether other 3 pillar societies have contributed already or only agreed to contribute.

After getting all relevant informations from Dr Bilimaga, EC was convinced by group email conversation dated 6th October, decided and refunded back Rs 10 Lacs to ICC with a condition, when the case will be settled, the total liability will be proportionately shared between all 6 societies and we may get back some amount from this 10 L. or give some more as differential amount.

EC decided that the seed money amount for IASO conferences needs to be revised and it should be matching the current market and need. President proposed the revised money amount.

We need to pursue this issue in consultation with NMC and NBE.
13. **IASO GST account**- There an urgent need to open a GST account. Dr Deo requested Dr Rudra P Acharya to pursue the issue on priority in consultation with IASO CA and other authorities.



14. Dr Ashutosh Mishra has made suggestions for change in IASO membership certificate designs and other website update. The proposal was seconded by president and secretary.
15. **Web Secretary** - Dr SVS Deo asked Dr Ashutosh Mishra to look after website along with Editorial secretary job, which was seconded by Dr Rudra Acharya and other EC members.
16. Dr Chandramohan Raised the agenda regarding eligibility of members for allowances. So it was decided unanimously that all ECs are eligible as per IASO rules including Co-opted members. Co-opted organising secretaries of Conference will not get this benefit.
17. Dr SVS Deo suggested that we can have one zoom meeting in next 6-8 weeks.

3rd INDIAN CANCER CONGRESS 2023

2nd-5th NOV, 2023, MUMBAI

ICC is a collaboration between the four largest professional oncology societies of India which together represent the majority of practicing surgical, radiation, and medical oncologists of India, as well as other specialists like onco-pathologists, onco-radiologists, etc. The four societies are the Indian Association of Surgical Oncology (IASO), The Indian Society of Oncology (ISO), The Indian Society of Medical and Paediatric Oncology (ISMPO), and The Association of Radiation Oncologists of India (AROI). ICC is jointly conducted once every 4 years by the four organizations in lieu of their annual conferences. The first and second editions of the ICC were conducted in Delhi in 2013 and Bengaluru in 2017, respectively.

The 3rd ICC was organized at the Jio World Convention Centre, Mumbai from November 2-5, 2023, with the theme "Continuum of Care in Cancer". Launch of The Lancet Oncology Commission on Global Cancer Surgery- Part II: Intent and content

By Dr. Chandrakanth Are, USA (Lead Commissioner)

A new report from the Lancet Oncology Commission on Global Cancer Surgery has identified nice domains and eight call-to-action points to address the global cancer surgery crisis, which disproportionately affects low- and middle income countries (LMICs), including India. The report, unveiled at the 3rd Indian Cancer Congress on 3rd November at Mumbai, it highlighted the fact that over 80% of people with solid tumours will need surgery, but only 25% of those living in LMICs are likely to receive it. This second Lancet Global Cancer Surgery report, written by more than 50 global experts, laid down solutions, including emphasising the role of surgery and surgeons in cancer care, upgrading technology routinely, quality surgery and better outcomes, increasing research on cancer surgery, and creating an adequate cancer surgical workforce. The report projects that current cancer surgical workforce will not be able to meet burden in 2040. "Millions of people around the world, especially in LMICs, lack access to safe, timely, and affordable cancer surgery.

This is a global injustice that the report aims to address by providing roadmap", said Dr Chandrakanth Are, lead of the commission. He said that as cancer was the second leading killer globally, the use of surgery must receive greater push. Among some of the key recommendations in the report include early initiation of cancer surgical training in the medical curriculum. Dr Sanjay Sharma, chairman of ICC, said only 20-25% of cancer surgeries require super specialization while the rest can be performed by general surgeons with training. Dr Are concurred the need for centralization of complex surgeries and decentralization of the common ones. An analysis of current trends revealed that the surgical workforce will be inadequate to meet the projected rise in cases in 2040, with a 383% gap in LMICs and a 25% gap in high-income countries. Prof SVS Deo played a role as a geographical commissioner for South EAST Asia for the Lancet Oncology Commission on Global Cancer Surgery and C S pramesh and Dr TS Rao also contributed for the same.

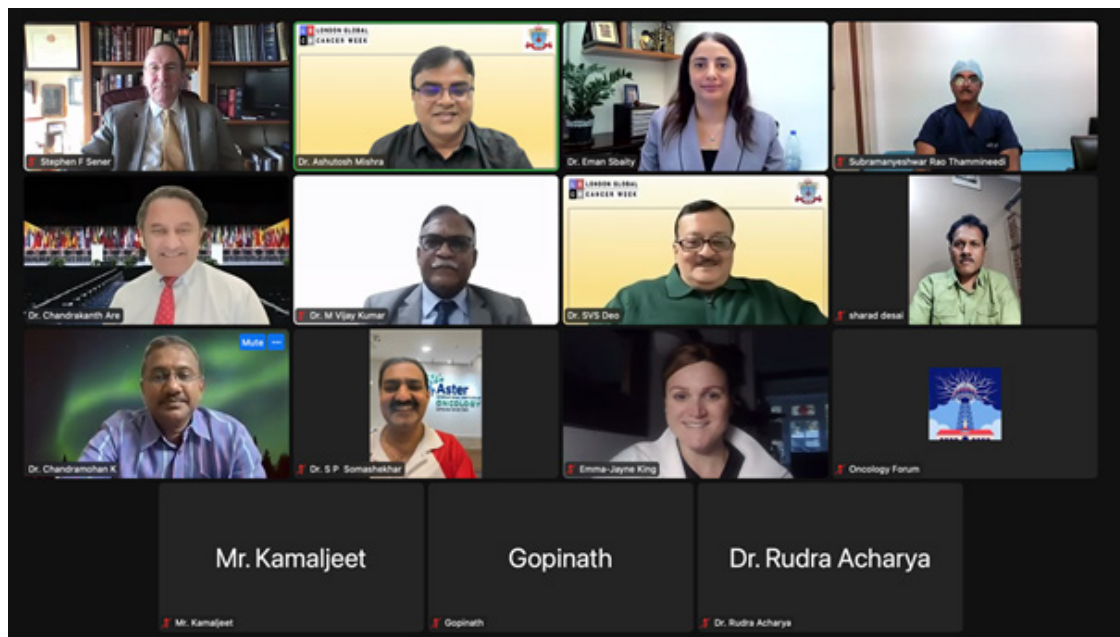

Outreach activity- PinKayathicon 2023

Breast cancer has become the commonest cancer in women in reproductive age group. Currently 1 in every 28 women is likely to develop breast cancer during her lifetime in our country. And unfortunately 60% breast cancer cases present in advanced stages where the survivals get as low as 25-40% whereas if they are diagnosed in Stage 1, the survival rates can be as good as 98-100%.

This underscores the dire need of making women fully aware of breast cancer, its early detection by screening, seeking medical help as early as possible, and more importantly, knowing preventive measures, including lifestyle changes so that breast cancer does not snatch precious lives from the family and society.

In this backdrop, the annual 'Breast Cancer Awareness Mega Event' of Kashmir, PinKayakithon 2023, envisaged by Dr Shabnam Bashir, was organised under the auspices of the Association of Breast Surgeons of India (ABSI), Indian Association Of Surgical Oncologists (IASO) in collaboration with Institute of Music & Fine Arts, Kashmir University, Srinagar on 19th October 2023. The event received full support by the Directorate of Tourism Kashmir, Government Nursing College Srinagar (affiliated with GMC, Srinagar), Government Nursing College Anantnag (affiliated with Anantnag). 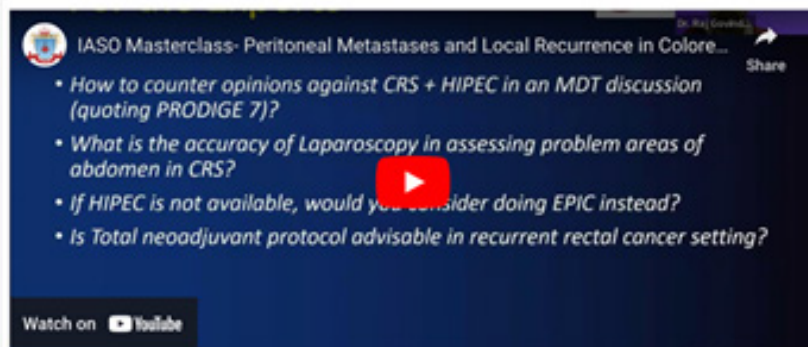
